Atchison County Food Pantry is continuing to operate an emergency drive through food distribution site operating out of Wolf Hall at the church. Distributions are scheduled every other Friday afternoon from 4:00 PM to 6:00 PM. Our last distribution on May 8th served 90 households and 262 individuals. We were able to give away 30 lb. boxes of staples, meat, bakery and produce, in addition to 6 lb. boxes of vegetable burgers donated to us by the Salvation Army. **Our next distribution is scheduled for Friday, May 22nd from 4-6 p.m.** As Salvation Army is ending their emergency distribution site at the end of May, we will be the only food pantry in Atchison operating a drive-through distribution. We intend to continue these at least through the month of June, and more than likely through the summer.

This month we received several generous donations and grants, including a \$1,000 donation from CWF at the church, a \$2,000 grant from the Louis C. McConaughey Fund at Trinity Episcopal Church to assist the food pantry in purchase of a newer van, an additional \$3,000 grant, also from the Lois C. McConaughey Fund to help sustain the food pantry, and a \$6400 grant from the Atchison Area Community Foundation's 2020 Covid-19 Recovery Fund to assist in emergency food distribution. The van grant put us over our goal of raising \$10,000, which the Church Board requested. Food pantry funds designated for the van total \$10,600. Trustees will add \$6,000 in undesignated funds, and also \$4,000 in funds that Bob Kibler left in his estate for church operating expenses, and requested by Larry and Tiny Kibler to be used to purchase a late model, low mileage van. Trustee funds will arrive around June 1st, and we should have a much better, roadworthy

van by the end of the month. Thanks to everyone who has helped with this.

The food pantry will continue to need donations of food, supplies and cash donations to sustain us. If you have unused Thrivent cards, or can afford to contribute to the pantry, this is a great time to do it. We accept cash and checks at the church office (PO Box 626, Atchison, Kansas), or donate through the First Christian Church website (fccatchison.net), if you have an account. If you would like to make a food or supplies donation, we need canned vegetables and fruit, hot or cold cereals, pancake mix and syrup, peanut butter, spaghetti or elbow macaroni and sauce, rice and beans, soups, ramen noodles , laundry and dish detergent and toilet paper. Donations can be left at the church office, which is currently open on Wednesdays (10 am to 4 pm) and Fridays (9:30 – 11:30 am).

Dear Church Family,

I pray this message finds you and your loved ones healthy and safe. This has been a challenging journey, but I know we will get through it with God's help and with the help & encouragement of one another!

Since the State of Kansas & the County of Atchison revealed their multi-phase plans for trying to get life as back to normal as possible, I'm sure many of you have been wondering about our plan at FCC.

Staff, the Worship Ministry Team, and our Board (which met last night via ZOOM) have been working diligently & prayerfully to come up with the best (and safest) course of action. *The purpose of this update is to outline our plan for moving forward. This plan may need to be modified (as the situation develops), but we wanted to communicate (as well as we can) the general direction we are heading.*

Before outlining our plan, I just want to say - We ALL miss worshipping together on Sunday mornings and are incredibly eager to get back into our beautiful sanctuary! At the same time, the last thing any of us want is to put our friends or family at risk of getting sick.

As our Staff, our Worship Ministry Team, and our Board have wrestled to come up with a plan, here are a few pieces of information we have taken into consideration:

- From Terri Hord Owens (General Minister & President of the CC(DOC), "I want to encourage you, as difficult as it is, not to rush too quickly back. It is not yet time to gather for worship in person." (April 30)

&

"I remain fully committed to advising all due caution and patience as we consider what could be life and death decisions. I think it is also helpful to consider the practicalities and costs associated with having people in facilities right now, including the costs of ensuring deep cleaning and disinfecting, and getting good counsel from legal and insurance partners." (May 13)

- From the **CC(DOC) College of Regional Ministers**, "*"First and foremost, we write to encourage you to be patient and take your time, and not rush back into full in-person activities before we are confident it is safe to do so."* (April 30)

- From **NEK Multi-County Health Departments, Inc.,** "Churches are encouraged to use online, radio or other telecommunications tools whenever possible to conduct services." (May 8)

- From the **Topeka Capital Journal**, (paraphrased) - Religious organizations have been exempted from limitations on gathering size (legally), but it's recommended that they follow government guidelines. (May 8)

- FOR REFERENCE, the current multi-phase plan for Atchison County (according to a document released May 1 by **NEK Multi-County Health Departments, Inc),** limits public gathering sizes (best-case scenario) to the following: 10 people (5/4 - 5/17); 25 people (5/18 - 5/31); and 50 people (6/1-6/30).

*Note that this is slightly different than the State of Kansas Guidelines.

The general consensus of the Atchison Ministerial Alliance (at least those who participated in our ZOOM meeting on April 1) was that our churches need to proceed with extreme caution and resist the temptation to move too quickly. Someone shared a quote that I thought was very appropriate,
"Just because we CAN, doesn't mean we SHOULD."

- Dr. Ruth Krusemark also drew our attention to an article that was recently published by the **Performing Arts Medical Association**. It reports that people who are singing can project the COVID-19 virus as far as 16 feet (not 6). The article also says, *"Masks don't provide safe methods of singing."*

Given these considerations (to name a few), our Staff, our Worship Ministry Team, and our Board have outlined the following (tentative plan) for worship at FCC:

- 1) MAY We will continue to offer weekly video broadcasts on Facebook & YouTube. We will also continue to share messages on KAIR radio, through our podcast and through our website. (We are looking into producing & delivering DVD videos of our broadcast to those without computer or internet access). No IN-PERSON services.
- 2) JUNE We will have a few in-person services, but participation will be limited to ESSENTIAL PERSONNEL ONLY (those involved in conducting the service). We plan to broadcast VIDEOS of these services (some pre-recorded & some live - until we get the hang of it). Essentially, this will be an UPGRADED version of what we are offering in May. LIMITED IN-PERSON SERVICES.
- * Toward the end of June, we would like to host an IN-PERSON service for everyone in the church parking lot (Drive-in style)!
- 3) **JULY** We hope to be able to offer **IN-PERSON SERVICES** for our general membership again. We would, of course, be exercising caution & observing social distancing protocols. Our plan is to broadcast **LIVE VIDEO** of the services as well.

As leadership, we know that some people will be disappointed or will disagree with our plan. All we can say, is that we are doing our very best to make wise, informed, collaborative, and prayerful decisions. We ask for your prayers and stress the importance of remaining UNITED during this challenging time.

We will keep everyone posted with new and relevant information as our situation continues to develop. This Sunday's Video Broadcast will also feature some information updates.
