FCC Church members,

I am writing you today to let you know of an important Congregational vote upcoming at our church. This vote will take place on September 20th at the end of our church service that day. The reason for this meeting follows.

The Elders of the church are our elected leaders and represent all church members' interests. The Elders have been reviewing the church's status under the leadership of Senior Pastor Matt Broxterman who has served in that capacity for four years now. Based on their findings, the Elders made a decision that effects all of the members of the church. The decision was made to move the church in a new direction and they requested that Pastor Matt resign his position, which he agreed to do. This resignation was received on August 20th, 2020.

On September 1st, I called a Special Board meeting to address this resignation as required by the By-Laws of our church. The Church Board voted to accept Pastor Matt's resignation at that meeting.

The final step in this process is for the congregation to vote to accept or deny Pastor Matt's resignation. To complete this step as required in the church's By-Laws, I am calling a **Congregational meeting to order on September 20**th **at the end of worship service that day. The only item on the agenda will be to vote to accept or deny Pastor Matt's resignation.**

These are difficult times that we live in and sometimes they require difficult decisions. The Elders contemplated their actions with thought and prayer. After careful consideration of all sides of this situation, they made their decision that has set this process in motion. We now must convene this meeting and determine the final outcome.

This letter will be the official notice to you of this upcoming meeting.

Atchison County Food Pantry held another drive through food pantry on Friday, August 28th. We provided food boxes including meat, soups, canned vegetables and fruits, spaghetti and spaghetti sauce, peanut butter, laundry soap, deli items, fresh produce and bakery from Feeding America to 140 households with 444 individuals in these households. Thanks to all of the volunteers and donations that help make this happen. We are planning another drive through pantry on Friday, September 11th. At this time, the pantry will be scheduled from 4:00 PM to 6:00 PM to help meet the needs of working families, but the scheduled time may change to earlier in the afternoon. We appreciate the assistance of KAIR Radio in helping us publicize these events. We are hoping to continue these food distributions outside of Wolf Hall through the month of October, if we continue to have good weather and we can schedule our events around other organizations that also use Wolf Hall.

We have scheduled a presentation from the Atchison Area Community Foundation for the next Church Board meeting on September 8th. The Community Foundation provided the food pantry a \$6400 donation in the spring to help the food pantry with additional expense incurred because of the pandemic. If the Board approves, the food pantry would like to set up an Endowed Fund with the Community Foundation. This fund would accept tax deductible contributions from members of the community and estates that would help fund the food pantry into the future years. The food pantry has been in operation for sixteen years and the need continues to grow. The food pantry has also applied for a grant from the Kansas Department of Commerce to build a fourteen foot roof structure over the entrance to Wolf Hall, which will provide shelter from the elements for both volunteers and clients of the food pantry during the winter months. This grant is subject to both Board and Kansas Department of Commerce approval.

We appreciate donations to the food pantry this month which totaled 176 pounds. This included generous donations from Effingham Union Church and a Thrivent Card in the amount of \$250 from a parishioner at St Mark's Lutheran Church. As always, we can use donations of hot and cold cereal, canned goods, laundry and dish soap, toilet paper, pancake syrup and mix, jam and peanut butter, spaghetti and spaghetti sauce, soups and coffee. Cash donations and Thrivent Cards are also very much appreciated and help us to conserve our cash.
